The Broadcaster has reviewed the budget and the financing plan submitted with the CMF application for the Television Component and finds the budget adequate, under normal circumstances, to deliver the completed Television Component.

The Television Component Applicant and the Broadcaster each hereby acknowledge that, should the production budget or the final production costs for the Television Component increase, in order to remain eligible for funding, the Television Component must have Eligible Licence Fees sufficient to meet the CMF's Licence Fee Threshold requirements in relation to the increased production budget or final production costs.

The Television Component Applicant and the Broadcaster each hereby acknowledge that in cases where provision of a licence is wholly or partially dependant on a buyback of services from the Broadcaster, the CMF may elect to deduct the value of the services or facilities from the total value of the licence for the purposes of determining Eligible Licence Fee amounts for Licence Fee Threshold assessment. This determination will be made on a case-by-case basis. Eligible Licence Fees cannot be reduced once the CMF has entered into a production financing agreement with the Television Component Applicant.

The Television Component Applicant and the Broadcaster each hereby acknowledge that broadcast licences that commence within the Maximum Term but extend beyond it will be pro-rated to match the Maximum Term set for each genre. Licences that commence after the Maximum Term will not contribute to the CMF's Licence Fee Threshold requirements (see Section 3.2.TV.5.2 of the 2010-2011 English POV Program Guidelines).

The Broadcaster hereby agrees to broadcast the Television Component closed captioned in peak viewing hours within 18 months of completion and satisfactory delivery of the Television Component to the Broadcaster. If the Broadcaster is an ancillary window broadcaster, it hereby agrees to broadcast the Television Component closed captioned in peak viewing hours within 18 months of commencement of its licence period.

The Television Component Applicant and the Broadcaster hereby acknowledge and agree that the Canadian Broadcast Right and the Canadian VOD Right does not include:

- Broadcast or VOD rights for non-Canadian territories or restrictions on the Television Component Applicant's ability to exploit these rights, with the exception of traditional broadcast spill-over protections and exclusive world premiere rights;
- Other Rights (free Internet broadcast/distribution, paid Internet broadcast/distribution, mobile/wireless distribution, original digital content rights, electronic sell-through and/or digital rental, DVD, Blu-ray, or other compact video device distribution, theatrical distribution, non-theatrical distribution and merchandising and ancillary rights) for Canadian or non-Canadian territories. These Other Rights must be separately identified and valued, both from the Canadian Broadcast Right and Canadian VOD Right, and from each other;
- An ownership, profit, repayment or recoupment position in the Eligible Project;
- Rights in excess of the Maximum Term as described in Section 3.2.TV.5.2. of the English POV Program Guidelines.

The Television Component Applicant and the Broadcaster hereby each confirm that they have not entered into any oral or written agreement or "side deal" that conflicts with any of the provisions of this Broadcaster Agreement Form or the CMF 2010-2011 Guidelines.

The Broadcaster hereby confirms that its licensing of the Television Component on the terms described herein is in compliance with Section 3.2.TV.5 of the English POV Program Guidelines.

All capitalized terms not defined herein shall have the meaning ascribed to them in the CMF 2010-2011 Guidelines.
